A.2. Description of the small-scale project activity:

The proposed CDM project activity comprises of installation and operation of three (3) nos. of 1.5 MW Wind Electricity Generators (WEGs) each having a combined wind power generation capacity of 4.5 MW. The WEGs are located in the Surajbari creek in Village Jangi, Taluka Bhachau, District Kutch, State Gujarat, India. It is one of the wind rich areas of the country. The annual estimated power generation for each of the 1.5 MW WEG is 34 Lakh units. All three WEGs are connected to the NEWNE (Northern, Eastern, Western, North-Eastern) grid and the generated electricity is sold to Gujarat Urja Vikas Nigam Limited (GUVNL) as per the Power Purchase Agreement (PPA). Details of the WEGs installed under the proposed CDM project are provided in *Table 1*.
